USER AGREEMENT

Conditions of use

The mission of Tri-State Christian Camp & Retreat Center is to provide a Christian camping environment, challenging youth to love and serve Christ. Secondly, this challenge extends to adults. **The USER AGREES to conduct a program consistent with the camp's mission statement.**

1. Those who rent TSCC for spiritual retreats must believe in the deity of Christ. The Bible teaches that Jesus is Immanuel, which means "God with us." John's gospel begins, "In the beginning was the Word and the Word was with God and the Word was God...The Word became flesh and lived among us." Note: We also provide rental facilities for non-spiritual

events.

2. All behavior and attitudes should be motivated by love. "Love the Lord your God with all your heart and with all your soul and with all your mind and with all your strength. The second is this: Love your neighbor as yourself. There is no commandment greater than these." (Mark 12:30-31) Those who stay here are called to love God and others in word and deed.

3. Sexual immorality is prohibited by God's Word, and therefore by TSCC. This includes premarital sex, extramarital sex, homosexuality, pornography, and any other sexual activity outside the bounds of a Biblical marriage. "Marriage should be honored by all, and the marriage bed kept pure, for God will judge the adulterer and all the sexually immoral." (Hebrews 13:4) Those who rent our property will be denied the privilege if any of these activities is condoned.

4. **Insurance.** The **USER AGREES** to provide medical insurance for their group. **Attach proof of current insurance coverage to this agreement form.**

5. **Sponsors.** The **USER AGREES** to provide adult sponsors at a ratio of one adult per every 10 children, providing women sponsors for girls, and men sponsors for boys.

6. **Clean up and Damages.** The **USER AGREES** to leave the buildings and grounds in the same good condition in which they found them. Prior to departure, trash should be picked up and all areas returned to their original condition. Except for normal wear, the **USER AGREES** to pay for damages to camp property caused by any member of the user group.

7. **Pets and other animals,** with the exception of guide animals, are not allowed on the camp grounds.

8. **No fireworks** of any kind are permitted on the camp grounds.

9. **No swimming** will be allowed without the supervision of a certified lifeguard.

10. **Dancing** is not permitted on the camp grounds.

11. In an attempt to foster a Christian environment, we encourage you to use discretion in your **music, radio, and movie** selections. TSCC has the final authority on all matters pertaining to music and movies.

12. **Decent and modest clothing** is required **AT ALL TIMES.** Two-piece swimsuits, Speedo swimsuits (men), short shorts, spaghetti straps and see-through tops are not permitted. No pajamas or lounge sleepwear are to be worn in public areas. **Shirts & Footwear** are to be worn at all times.

13. **Controlled substances.** The **USER AGREES** that no alcoholic beverages, tobacco products, or drugs deemed harmful and intended to induce a "high" will be brought to or consumed at the camp. Tri-State Christian Camp is a non-smoking environment.

14. The **USER AGREES** to the financial conditions set forth on page 2.

15. The **USER AGREES** that the camp Director has final authority in all matters affecting the buildings, grounds, and policies. We reserve the right to require any or all members of a group to leave the camp should their behavior be in violation of camp policy. In the event this is necessary, the **USER AGREES** to comply and to pay the total charges for the use of the camp.
